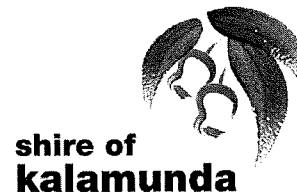

All stallholders to have a thermometer on-site*

Cold Foods (eg: fridge, esky with ice bricks)
